You can score the following items on a 5-point scale:

0. No, this is forbidden or denied
1. There is no clear policy on this, but it is discouraged
2. There is no policy on this
3. It is encouraged, but there is no clear policy on this
4. Yes, there is evidence to support this
5. No data available

If there is a difference in the legal and social situation, answer for the social situation.
